

# ONLINE PRIVACY POLICY AGREEMENT

Hanger One Safety Products (Hanger One) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Hanger One Safety Products of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. ### **Why We Collect Information and For How Long**

We are collecting your data for several reasons:

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

### **Use of Information Collected**

Hanger One Safety Products does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Hanger One Safety Products may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from <https://hangeronesafetyproducts.com/>

- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Hanger One Safety Products.

### **Non-Marketing Purposes**

Hanger One Safety Products greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in Hanger One Safety Products products and services). ### **Children under the age of 13**

### **Notice to European Union Users**

Hanger One Safety Products's operations are located primarily in the United States. ### **Security**

This is all done to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

The company also uses Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information. In addition, Hanger One Safety Products is a licensee of TRUSTe.
